
Northwood, NH



Incorporated: 1773

Origin: This territory was first settled in 1763, and known as the North Woods, a parish of Nottingham. It was incorporated as a separate town upon agreement with Nottingham in 1773. In 1791, the General Court of New Hampshire authorized a committee to survey and lay out a road between Durham and Concord, which became the First New Hampshire Turnpike. The road runs the length of Northwood, and the town's many taverns accommodated travelers. At one time, there were some 12 sawmills in the town, five of which were replaced by shoe factories.

Population Trends: Population change for Northwood totaled 3,117 over 50 years, from 1,525 in 1970 to 4,642 in 2020. The largest decennial percent change was a 44 percent increase from 1970 to 1980, following a 43 percent increase from 1970 to 1980. The town's population increased by nine percent from 2010 to 2020. The 2022 Census estimate for Northwood was 4,677 residents, which ranked 81st among New Hampshire's incorporated cities and towns.

Population Density and Land Area, 2022 (US Census Bureau): 166.3 persons per square mile of land area. Northwood contains 28.1 square miles of land area and 2.1 square miles of inland water area.
